## <u>Minutes</u>

Mr. Jackson made the motion to approve the minutes of the July 2, 2018 meeting as submitted. Mr. Edwards seconded the motion, which was approved by a 7-0 vote.

## **Closed Meeting**

Upon a motion by Mr. Wilson, seconded by Mr. Collins and approved by a 7-0 vote, the Authority entered into a closed meeting, for acquisition/disposition of property, prospective business in accordance with Section 2.2-3711 (A.3, A.5) of the Code of Virginia.

## Return to Regular Session - Certification

On a motion by Mr. Chambers, seconded by Mr. Collins, and approved by a 7-0 vote, the IDA returned to regular session and adopted the following resolution.

Mr. Wilson made the motion to approve the monthly claims report as presented by Ms. West. The motion was seconded by Mr. Edwards and approved by a 7-0 vote.

## Treasurer's Report

Mr. Chambers made the motion to approve the treasurer's report. The motion was seconded by Mr. Jackson and approved by a 7-0 vote.

## Laurel Fork Fire Truck Purchase

Mr. Chambers made a motion to approve three items concerning the purchase of a pumper for the Laurel Fork Volunteer Fire Department. They included:

- A. The governing body loan resolution for the Laurel Fork FD truck;
- B. The loan terms resolution for USDA for the Laurel Fork FD truck;
- C. The Code of Conduct governing performance of resulting loan contracts for the Laurel Fork FD truck.
