Network:

Outages:

GFT <> PTLO - software issue causing traffic to stop flowing. Issue causes the routers at each side of
the link to lose communication with each other and stop passing network traffic. Issue is resolve when
PTLO_PTP_GFT is restarted. Radio firmware updated, will continue to monitor. UPDATE: Radio
firmware did not resolve the issue, however - we adjusted the channel size which relates to the radios
distance settings and the issue resolved.

Maintenance:

- Wireless Upgrades Galax Fire Tower 5/30/19
- BMRS wifi router & Grange Hall batteries to be installed by Lingo.
- Temporary fiber installation and splicing Galax
- Fiber break I-77 Area Hillsville: A subcontractor for Citizens damaged mainline cable located between I-77 and the Carroll County industrial park. The fiber was properly located and the contractor was digging close to the marked location. The contractor called in an additional 3 Hour Rush locate presumably after the damage occurred. While responding to the locate RCS initially worked with the contractor and took photos of the damage. Lingo was dispatched to assess and resolve the issue. The contractor re-buried conduit/fiber under Lingo's supervision. A new section of 144 strand fiber will be pulled in and spliced replacing the area of concern Lingo is quoting this work.

Other:

Construction:

- USC initially scheduled to start work on the aerial plant 5/27/2019
- Pre-construction ride-out performed by USC week of 5/13 and several questions arose regarding the
 poles and make ready. Around 12 poles were called into question, the issue being whether or not
 there's sufficient space to attach. Half have been resolved/clarified.

The Wired Road Authority

The Wired Road Authority has been awarded an Appalachian Regional Commission Grant and has obtained other

funding to construct a five mile fiber extension and drops in Carroll County. Under this grant, a connection to Γhe Wired Road regional broadband network can be provided at your location, an approximate \$1,750-\$2,500 value. You will then be able to purchase services from the service providers that operate on The Wired Road.
Yes, I accept a fiber connection to The Wired Road network that will provide my home/business with access to telecommunications services from several competing providers.

IMPORTANT: If you are renting. This agreement must be signed by the Owner of the Property.
OWNER: By my signature below, I, as the owner of this property, authorize The Wired Road Authority to connect this structure to The Wired Road Broadband Network. I also grant permission to the Authority's Construction Contractor and other agents to enter my property for the purpose of constructing and inspecting said construction connection. This permission is predicated on the basis that the contractor will restore my property to a condition equal to or better than when the work commenced. If the work to be performed is only for installation of a connection to The Wired Road, no additional documentation of my authorization is necessary. If the work to be performed includes construction of any other kind, my signature on an additional contract will be required prior to the commencement of work.
